The Cambridge Health Alliance/Harvard Medical School Clinical Psychology Internship Training Program accepts applications from doctoral psychology students in either clinical or counseling or school PhD or PsyD programs that are accredited by APA or CPA. All applicants are expected to have completed all coursework for their home institution as well as have a department-approved dissertation proposal prior to the start of the internship training program. Applicants are expected to have accrued a minimum of 200 supervised practicum direct contact intervention hours. There is no required minimum number of direct contact assessment hours.
